
A Message from Mayor DiMaria

I am proud to report that 2023 was another great year of exciting accomplishments and progress for the Village of Morton Grove. We developed and adopted a new Strategic Plan to determine where the Village wants to go as an organization, a community, and a government. We set the stage for major redevelopment projects to begin construction this year, including a new Napleton Honda dealership at Dempster and Waukegan, 89 townhomes by Lexington Homes at 8350 Lehigh, and a 36-unit mixeduse development at Chestnut and Lehigh. We celebrated the completion of Phase I of the Oakton Street multi-use path and are working on next phases with our neighboring communities.

I take the greatest pride in reporting that the new Morton Grove Metra Station and Gateway Plaza (Lincoln and Ferris) projects will be shovel-ready for Spring 2024. These are legacy projects that will reflect the quality and appearance that our residents and community deserve and truly transform the Village's transitoriented district. Lastly, we are working diligently toward the

design of a new combined Village Hall and Police Station at 6201 Dempster Street, the current site of Fifth Third Bank. In 2024, the bank will construct a new branch across the street on vacant land at 6210 Dempster as part of a partnership deal between the Village, Morton Grove Park District, and Fifth Third Bank.

Lots of exciting things have happened in the Village this past year, and we have so much to look forward to in 2024. I want to thank our Village Board, board and commission members, staff, residents, and businesses for contributing to the vibrancy and strength of Morton Grove. Together, we move forward as a community of neighbors toward our shared goals and a bright future.

Fifth Third Bank

6210 Dempster

Fifth Third Bank is in permitting for a new bank branch at 6210 Dempster. The development is part of a multiproperty deal that includes the Village's purchase of Fifth Third's current site at 6201 Dempster for a new Village Hall and Police Station. The new branch will be completed in 2024.



Park Villa Townhomes

Ferris, Hennings & Narragansett

Ten luxury townhomes are under construction along Hennings between Ferris and Naragansett. P & P Properties plans to deliver the homes in 2024.

Napleton Honda

6900 Dempster Street

Napleton Honda is demolishing all existing buildings at the current location and constructing a new 40,000-square-foot dealership to be completed by Q1 2025.



36-Unit Mixed Use Project

8500-50 Lehigh

MHDC SLF LLC has obtained approvals for a four-story mixed-use project proposed at Chestnut and Lehigh. Plans are in place for three restaurant and cafe tenants on the ground floor. Construction will start in 2024.

Sustainability Updates

Third Morton Grove Sustainability Expo a Success

The Environment and Natural Resources Commission (ENRC) and Village staff hosted the third annual Sustainability Expo at the Morton Grove Civic Center on September 9, 2023. This year, a Recycling Fest was added to the event to collect recyclable items of all kinds. The event featured 37 exhibitors, live music, a solar house, electric vehicle display, and kids activities. Residents and visitors learned about energy-saving products and greener everyday living. New Composting Service

Effective January 2024, WasteNot, Inc., is serving as the Village's new curbside compost collection hauler for homes, businesses, and schools. The decision to change haulers was driven by service offerings, cost considerations, WasteNot's

commitment to using 100% electric vehicles, and the Village's commitment to providing exceptional customer service after a competitive bid process.

WasteNot's year-round service makes composting more accessible and convenient for Morton Grove residents. Participants receive an airtight five-gallon receptacle to hold a variety of compostables, including all food waste, paper products, certified compostable products, and more. Both weekly and bi-weekly service is offered. Learn more and register at wastenotcompost.com/mortongrove.



New Dempster Pulse Line Service

The Village joined Pace Suburban Bus and Morton Grove's elected officials in November 2023 for an event celebrating the opening of the new Pulse Dempster Street line. Pulse is Pace's expanding network of arterial bus rapid transit service, which provides premium bus service to

commuters featuring enhanced amenities and a streamlined route design on heavily traveled Chicagoland corridors. Morton Grove's five new Pulse stations range from completed to still under construction, but full daily service has already started. Pulse service offers limited stops, traffic signal prioritization, modern stations, and buses that run every 15 to 20 minutes. Pulse riders can get from Morton Grove to O'Hare Airport in 30 minutes for only \$2.00 using their Ventra Card (\$2.25 cash). The Dempster Pulse Line is a major improvement to Morton Grove's public transit network and provides a new alternative to personal vehicles. New Metra Station Coming 2024

The Village is working with Metra to finalize engineering and architectural plans for construction of a new Morton Grove Metra station at 8501 Lehigh Avenue. Staff is preparing to put the project out to bid in Q1 2024. Construction is planned to begin in Q2 2024 and be completed by the end of the year. The project includes the construction of a new station in a new location north of the existing station and reconstruction of the existing parking lot to improve

site access, circulation, accessibility, and landscaping. The new station will include an after-hours heated waiting area, tenant retail space, ticket vending machines, and a public restroom.

Metra is contributing \$300,000 toward construction of the station, which will cost approximately \$3 million. The balance of the cost will be paid for by the Lincoln/Lehigh TIF District, but staff is reviewing opportunities for grant assistance. The new station will create a new focal point for the Village's transit-oriented district, encourage Metra ridership, and improve the face of Morton Grove residents, commuters, and visitors.



Gateway Plaza To Be Constructed in Spring 2024

The long-awaited Gateway Plaza at Ferris and Lincoln is finally coming. Construction was pushed to Fall 2023 due to engineering and design needs, then put out to bid in August, but bids came in significantly over budget. Staff has worked diligently to deliver a high-quality product that is within budget. The revised design will be consistent with all plans that have been presented to the community. The project will be put out to bid again this winter and construction is planned to start in Spring 2024. A ribbon cutting for commemorative brick and bench purchasers will be held upon completion.



New Village Hall & Police Station in the Works

The Village is under contract to purchase the current Fifth Third Bank site at 6201 Dempster for a combined Village Hall and Police Station facility. The Village will close on the property and begin its renovation and addition work when Fifth Third opens at its future location at 6210 Dempster. The current Village Hall and Police Station at 6101 Capulina was remodeled as a temporary facility in 1980.

Building & Public Works

The Village Reminds You to Get Your Permit

The Department of Building and Inspectional Services reminds residents and property owners to check with Village staff before beginning any construction project, whether DIY or by a contractor, because a permit may be required. A permit will ensure work complies with building and safety requirements. Projects that are not built to Village standards may endanger your household, negatively impact your home's resale value and insurance costs, and require costly corrections after-thefact. Additionally, homeowners may receive citations for work completed without a permit. To find out if your project requires a permit, call 847-470-5214.

The Village offers online permitting for fences, sewer repair, water heaters, furnace/ air conditioning replacements, HVAC alterations, and solar panels. To access the permitting module, visit www.mortongroveil. org/building-and-inspectional-servicesdepartment. All other permit applications must be submitted in-person or by mail to the Building Department at 6101 Capulina. The Village plans to expand online permitting capabilities in the future with its transition to BS&A Cloud software in 2024.

50/50 Tree Planting

The Village is offering residents an opportunity to participate in the 2024 50/50 Tree Planting Program. The program allows participants to choose a certain type of tree to be planted in the public parkway by paying 50% of the cost. The Village will pay the other 50%. This year's cost for the resident is \$60 per tree. The deadline to submit a request to participate is April 1, 2024. Phase I of the Oakton Street Multi-Use Path **Completed**

In October 2023, the Village and representatives from federal, state, county, and municipal governments gathered for a ribbon cutting ceremony to celebrate the completion of the first phase of the Oakton Street multi-use path, a 0.55-mile stretch of paved path along the south side of Oakton between Caldwell and Lehigh. The path provides a safe, off-street facility for walkers, runners, and cyclists.

Two more project phases are planned. Phase II will provide a better, alternate path for cyclists at Oakton Street and Caldwell Avenue, and a segment along the north side of Oakton between St. Paul Woods and River Drive, offering access to St. Paul Woods. Phase III will extend the path across the Metra tracks to the east, reaching Niles West High School. Additionally, the Illinois Department of Transportation will replace the bridge deck over Edens Expressway. This is a great example of government at all levels working together to invest in bicycle and pedestrian infrastructure.

Join the Morton Grove Citizens Police & Fire Academy

The Police and Fire Departments are seeking participants for the 2024 Citizens Police and Fire Academy. The Academy is a twelve-week program with one block of instruction per week and is designed to give community members an understanding of Morton Grove Police and Fire Department operations and a working knowledge of law enforcement and firefighting.

The 2024 Academy will run from March 6 to May 22. Classes are held every Wednesday at 6:30 p.m. and are approximately two

hours in duration. The classes will be held at the Morton Grove Village Hall at 6101 Capulina Avenue at 6:30 p.m. Classes are limited to 20 students, so register early. There is no cost for residents to participate. The academy will conclude with a graduation ceremony and each participant will receive a certificate of completion

The Fire Department is proud to take part in the "Be Alarmed" program, a fire safety education and smoke alarm installation program administered cooperatively between the Illinois Fire Safety Alliance (IFSA) and the Office of the Illinois State Fire Marshal (OSFM). The program distributes fire safety education materials and 10-year sealed battery ionization technology smoke alarms to fire departments in the state of Illinois.

What is more exciting is that the program is FREE to eligible residential dwellings. It is easy to enroll in the program and smoke alarm installation is provided by the Morton Grove firefighters at no cost.
