AMENDING RESOLUTION 21-53 TO CHANGE THE TIME OF THE JOINT REVIEW BOARD MEETING FOR THE LINCOLN/LEHIGH REDEVELOPMENT PROJECT AREA

Introduced: August 25, 2021

Purpose: To comply with the Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 to

amend Resolution 21-53 to change the time of the Joint Review Board meeting for the

Lincoln/Lehigh Redevelopment Project Area from August 26, 2021 at 3:00 p.m. to August 26,

2021 at 10:00 a.m.

Background: On August 9, 2021, the Village Board approved and passed Resolution 21-53 which set the

time and place for the first meeting of the Joint Review Board ("JRB") of the Lincoln/Lehigh Redevelopment Project Area to Thursday August 26, 2021, at 3:00 p.m. On August 11, 2021, the Village, through its TIF consultants sent notice of the JRB meeting to all affected taxing districts. The notice was mailed at least fourteen (14) days but not more than twenty-eight (28) days before the August 26, 2021 JRB meeting as required by Section 11-74.4-5 of the TIF Act. However, the notice listed the time of the JRB meeting as Thursday August 26, 2021, at 10:00 a.m. instead of Thursday August 26, 2021, at 3:00 p.m. as set forth in Resolution 21-53.

To comply with the requirements of Section 11-74.4-5 of the TIF Act and reconcile the discrepancy between Resolution 21-53 and the JRB meeting notice, it is necessary to amend Resolution 21-53 to change the time of the JRB meeting to Thursday August 26, 2021, at

RESOLUTION 21-54

AMENDING RESOLUTION 21-53 TO CHANGE THE TIME OF THE JOINT REVIEW BOARD MEETING FOR THE LINCOLN/LEHIGH REDEVELOPMENT PROJECT AREA

WHEREAS, the Village of Morton Grove (Village), located in Cook County, Illinois is a home rule unit of government under the provisions of Article 7 of the Constitution of the State of Illinois, can exercise any power and perform any function pertaining to its government affairs, including but not limited to the power to tax and incur debt; and

WHEREAS, on August 9, 2021, the Village Board approved and passed Resolution 21-53 which set the time and place for the first meeting of the Joint Review Board ("JRB") of the Lincoln/Lehigh Redevelopment Project Area, also to be known as the Lincoln/Lehigh Tax Increment Financing ("TIF") District to Thursday August 26, 2021, at 3:00 p.m.; and

WHEREAS, on August 11, 2021, the Village, through its TIF consultants sent notice of the JRB meeting to all affected taxing districts. The notice was mailed at least fourteen (14) days but not more than twenty-eight (28) days before the August 26, 2021, JRB meeting as required by Section 11-74.4-5 of the TIF Act. However, the notice listed the time of the JRB meeting as Thursday August 26, 2021, at 10:00 a.m. instead of Thursday August 26, 2021, at 3:00 p.m. as set forth in Resolution 21-53; and

WHEREAS, to comply with the requirements of Section 11-74.4-5 of the TIF Act and reconcile the discrepancy between Resolution 21-53 and the JRB meeting notice, it is necessary to amend Resolution 21-53 to change the time of the JRB meeting to Thursday August 26, 2021, at 10:00 a.m.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF MORTON GROVE, COUNTY OF COOK, STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1: The Corporate Authorities do hereby incorporate the foregoing WHEREAS clauses into this Resolution as though fully set forth therein thereby making the findings as hereinabove set forth.

SECTION 2: Resolution 21-53 is hereby amended so that Section 2 of said resolution shall read as follows:

Joint Review Board Convened. A Joint Review Board ("JRB") as set forth in the TIF Act is hereby convened and the Board shall meet, review such documents, and issue such report as set forth in the TIF Act. The first meeting of said Joint

Review Board shall be held on August 26, 2021 at 10:00 a.m. at 6101 Capulina Avenue, Morton Grove, Illinois. The Village hereby expressly finds and determines said date is at least fourteen (14) days but not more than twenty-eight (28) days after the notice to affected taxing districts hereinafter authorized in Section (c) of this Resolution will be mailed. The JRB shall be established for the purposes set forth in the Act. The JRB shall consist of one representative selected by each community college district, local elementary school district and high school district or each local community unit school district, park district, township, fire protection district, and county having authority to directly levy taxes on the property within the proposed amended Redevelopment Project Area, a representative selected by the Village and a public member. The public member and the JRB's chairperson shall be selected by a majority of other members of the JRB in conformance with the requirements of 65 ILCS 5/11-74.4-5(b).

SECTION 3: In all other respects, Resolution 21-53 shall remain unchanged.

SECTION 4: Superseder; Effective Date. All ordinances, resolutions, motions or orders in conflict with the provisions of the Resolution are, to the extent of such conflict, are hereby repealed. This Resolution shall become effective upon its adoption.
