### I. L. E. A. P. Accreditation

The Illinois Law Enforcement Accreditation Program (ILEAP) is a two tier program designed for law enforcement agencies to attain excellence in policing. The Morton Grove Police Department holds Tier 2 Accreditation by having complied with over 180 law enforcement standards pertaining to Administration, Operations, Personnel and Training. An accredited agency will remain so for a term of four (4) years which is when the agency will be required to complete and submit an Annual Verification of Compliance package. During the fourth year of their accreditation term, ILEAP staff will contact the agency and arrange for a re-accreditation on-site assessment. In February 2021, the Morton Grove Police Department achieved reaccreditation by the Enforcement Accreditation Program (ILEAP) which is administered by the Illinois Association of Chiefs of Police. The Morton Grove Police Department has been accredited since 2017 and will go through the process again in 2024. The department has met the



standards for Tier Two Accreditation since 2017, which is the highest level of review offered by ILEAP.

### L. E. A. D. The Way

In 2022, the Community Liaison Unit continued to teach the Learning Effective & Assertive Decision-Making (L.E.A.D.) program which focuses on positive decision-making skills for middle school students and also teaches them about the dangers that they may face. Created by the Huntley Police Department in partnership with their schools, L.E.A.D.




the Way teaches the importance of being assertive and making choices that keep students safe whether they are at home, at school, or out with friends. The program is geared toward 5<sup>th</sup> graders and is designed to engage the students through group work, individual reflections, and activities as they work towards a healthy and safe future. L.E.A.D. the Way is a 9-week program with the last week being graduation. Each 35-45-minute L.E.A.D. the Way class discusses popular topics that middle school students are currently encountering. The topics include: tobacco, marijuana, alcohol & medication, peer pressure, being assertive, bullying, cyber bullying, internet safety, and encouraging words. It is taught by Officers Lietz and Jurasz.

In 2022, we partnered with Golf, Jerusalem Lutheran, Molloy and MCC to continue the program. Due to the COVID 19 pandemic, we were unable to do the program with some of the schools that usually participate. The police department wants to help build bright futures for the students in our community and we believe the positive interaction between the police department and the schools will be beneficial for the children.

#### **Patrol Operations Division**

The Patrol Operations Division is comprised of several individual work units that work in concert to deliver services for residents and visitors to the Village of Morton Grove. Within the patrol division there are three uniformed Patrol Shifts, the Traffic Unit, the Animal Control Unit, and the Social Services Component.

Our uniformed police officers assigned to the Patrol Shifts are highly trained and dedicated professionals who deal with a myriad of incidents on a daily basis. This might range from traffic safety and accident investigations to being the first responding units in critical incidents. MGPD personnel are dedicated to the highest ideals of the policing profession and strive to deliver the best possible services no matter the nature of the incident. Our officers have the lawful authority to enforce all ordinances of the Village of Morton Grove as well as the criminal statutes of the State of Illinois. However, the enforcement of laws is only one tool that the Department employs to protect life and property within the Village boundaries. The patrol shifts are supported in their efforts by civilian Community Service Officers (CSO), who serve as the face of the Department to anyone who comes to the station or contacts us by telephone. Our CSO's often assist the public in finding answers to questions or enabling the response of police officers when needed. The Traffic Unit engages in numerous activities designed to educate the public and gain voluntary compliance with traffic regulations, particularly in regards to occupant protection, speed awareness, distracted driving, and impaired driving. Our Animal Control Unit routinely rescues animals in distress and provides citizens with a resource to navigate their way through issues related to both domestic animals and wildlife. Our Social Services Component is staffed by a Licensed Clinical Social Worker who brings a wide variety of professional capabilities to assist residents in need.

All of these components work together to try to find the best possible outcomes that they can to meet the needs of Village residents and visitors. The Department and its personnel recognize that the power of the police to fulfill their functions and duties is dependent on public approval of their existence, actions and behavior, and on their ability to secure and maintain public respect.



#### 1<sup>st</sup> Shift: 2300 – 0700 hours

In 2022, the 1<sup>st</sup> Shift was staffed by one Commander, one Sergeant, eight Patrol Officers, and five part -time Community Service Officers. The 1<sup>st</sup> Shift strives to keep the community safe through proactive patrolling and investigations. They typically focus on residential patrol, premise checks, suspicious activity, traffic enforcement, and intoxicated motorists. During 2022, the 1<sup>st</sup> shift responded to 3,239 calls for service, conducted 1129 premise checks, and made 205 custodial arrests. Of those arrests, 9 were felonies and 57 were DUI related.

The shift members are highly trained professionals thanks to hundreds of hours of training every year. The 1<sup>st</sup> Shift was staffed by instructors for range, defensive tactics, tactical medicine, CPR as well as evidence technicians, field training officers, juvenile officers, breath analysis operators and two Drug Recognition Experts.

The shift's Top Cop for 2022 was Officer Dahm. Officer Dahm is a Field Training Officer, Defensive Tactics Instructor, Tactical Medical Instructor, and Drug Recognition Expert. Ofc. Dahm can be counted on to take ownership of these specialty assignments, and always seeks to better his own knowledge and in turn passes that on to those he works with. In 2022, Ofc. Dahm handled 246 incidents, made 161 traffic stops, had 42 custodial arrests, 22 of which were for DUI related offenses. He also served as an FTO for 60 work days during the year.

#### 2<sup>nd</sup> Shift: 0700 – 1500 hours

In 2022, the 2nd Shift was staffed by eight permanently assigned Patrol Officers, a Community Service Officer, an Animal Control Officer, two Sergeants, and a Watch Commander. During the year the 2nd Shift responded to 3,500 calls for service and made 20 custodial arrests as a result of criminal investigations. 2nd Shift personnel conducted over 900 premise checks of local businesses, parks, and school facilities. Officers spent time at identified traffic problem areas conducting 62 Enforcement Initiatives making 295 traffic stops and issued 318 citations for various offenses. Officers wrote 675 reports during the year.

Patrol Officers of the 2<sup>nd</sup> Watch provide responsive services to the Village of Morton Grove throughout the day. In addition to their normal duties many shift members are assigned ancillary duties. These duties include preparing for upcoming Scenario Based Trainings, evidence custodian & destruction tasks, monthly range training, evidence technician training, and defensive tactics training. All Patrol Officers, Sergeants, and Watch Commanders conduct these training tasks throughout the year. The two shift Sergeants are in charge of Animal Control, Department Safety Committee, Mass Notifications system, Department Training, Department Accreditation & Class A Uniform Displays.

The 2nd Shift Top Cop for 2022 was Officer Sean Lang who served as a Range Instructor, Tactical Medical Instructor, Field Training Officer, Evidence Technician, and Evidence Instructor while being assigned to MCAT. Officer Lang conducted over 120 hours of training within the Department. Officer Lang is self-motivated, works well with others, seeks out additional work assignments and responsibilities, and is dedicated to providing a high level of service for the Department and to the

community.

#### 3<sup>rd</sup> Shift: 1500 – 2300 hours

In 2022, the 3<sup>rd</sup> Shift was staffed by one Watch Commander, two Sergeants, eight Patrol Officers, and one full-time Community Service Officer. Officers on the 3<sup>rd</sup> shift focus on community safety, while building positive relationships through daily contact with citizens and business owners. Officers responded to 3,921 calls for service and made 72 custodial arrests.

Officers on the 3<sup>rd</sup> Shift pride themselves in being highly trained and well prepared. They received hundreds of hours of in-house and external training. The 3<sup>rd</sup> Shift was staffed by defensive tactics instructors, range instructors, TASER instructors, tactical medical instructors, evidence technicians, field training officers, juvenile officers, and a CPR instructor.

The 3<sup>rd</sup> Shift's Top Cop for 2022 is Officer Tomasz Prokop. Officer Prokop responded to 712 calls for service and made 11 custodial arrests. He is a field training officer, evidence technician, and breath operator. He served as a field training officer for 417 hours this year, helping to ensure that our new officers are well prepared and highly qualified to serve the Village.

Officer Michael Crowe, also a member of the 3<sup>rd</sup> Shift, is the 2022 Morton Grove Police Department Officer of the Year and Community Service Officer Susan Platz is the 2022 Morton Grove Police Department Civilian Employee of the Year.


#### **Social Services**

Liz Schild, Licensed Clinical Social Worker, is a full-time employee with the Village of Morton Grove and Police Department. Liz continued to strengthen collaborative relationships with a variety of community resources and stakeholders including townships, schools, State's Attorney's Office/court, mental health providers, hospitals, senior services agencies and substance use treatment advocates. She has researched creative ways to support areas of need within our community by collaborating with nearby villages to learn how they operate programs for residents. Liz is an active member of the Association of Police Social Services (APSS), a group of mental health professionals dedicated to the development, practice and enhancement of social services within police department settings and serves on their Law Enforcement Advisory Board. Liz is also a member of our Peer Support Team and the Village's Advisory Commission on Aging. She engages in community outreach by regularly attending various meetings, including LAN41 Niles Township, AHAND (Association of Homeless Advocates in North District) and Domestic Violence Stakeholder meetings.

The social worker role encompasses many different areas. Liz provides services to the entire Village of Morton Grove via referrals from the police department, fire department, Village and residents themselves. In 2022, she received the following number of referrals: 164 from the Police Department, 14 from the Fire Department and 13 from the Village. Below are some duties that she routinely completes:

- Provides crisis intervention, support and short-term counseling in situations involving domestic violence, family conflict, juvenile issues, substance abuse and/or mental health issues while providing referrals for long-term assistance and services
- Provides referrals for a variety of social service needs including housing, financial, food, senior services, healthcare, transportation, mental health and substance use
- Refines service delivery and the development of new programs and services
- Assists residents with limited income in applying for Village financial assistance
- Assists senior residents with applying for license plate discounts and other government programs
- Serves as an advocate in court for victims of crime, including Domestic Violence
- Acts as liaison with the Cook County State's Attorney's Office and the Cook County Courts System
- Acts as liaison with social service providers in the area and regional agencies/entities as directed
- Compiles statistics and prepares monthly reports on social service activities
- · Provides a variety of wellness and mental health resources to police department staff
- Attends professional development trainings on a variety of topics including vicarious trauma, officer wellness, substance use, adult guardianship, suicide prevention and mental health

#### **Projects**

Liz has embarked on several new projects and initiatives. These include innovations directed towards both process and service offerings. Some of these include:

- Partnering with other municipalities to apply for a Cook County Public Health grant for enhancing our juvenile adjudication hearing process by offering a range of restorative, supportive services to youth and families
- Collaborating with a community agency to secure a grant funded Seniors Matter Rideshare Pilot
   Program to assist in meeting the need of senior transportation in the Village of Morton Grove
- Attending monthly CESSA Meetings run by the Illinois Department of Mental Health to stay informed about new laws regarding public safety and mental health crisis services available to our residents

#### **Animal Control Officer**

The Morton Grove Police Department's Animal Control Officer (ACO) Glowacz, was thrilled to provide another successful year of assisting with a myriad of animal calls.

ACO Glowacz was able to facilitate the care and rehoming of 8 stray/abandoned dogs, as well as 3 cats, 1 kitten, and 3 exotic pets, into their new, forever homes. In addition to facilitating the rehoming of abandoned and stray animals, ACO Glowacz was able to provide animal surrender services for 3 canines in need. Animal surrender services are provided to residents who can no longer care for their pet, and need help finding a new home for them. In addition, ACO Glowacz and MGPD Patrol Officers pride themselves on reuniting canines with their owners; including securing at-large dogs in the community and assisting with found pets.



Training continued to be at the forefront of the Morton Grove Police Department's 2022 initiatives. ACO Glowacz spearheaded the update of the animal control section of our field training program for newly-hired patrol officers. This included training probationary officers on animal control ordinances, as well as procedures for safe animal handling/transportation. In addition to this hands-on training, ACO Glowacz constructed an Animal Control CSO Training Manual; another valuable resource for officers that are dispatched to animal control incidents. These written policies and procedures provide standards, and give instructions, for every part of animal control operations.

Animal rescue and rehabilitation efforts continued to play a key role in the police department's services this year. Interactions with wildlife are a part of everyday life for Village of Morton Grove residents. It is ACO Glowacz's goal to ensure a positive relationship between people and wildlife; as these animals are an essential component of our landscape. ACO Glowacz regularly provided care and relocation to wildlife animals found within the Village of Morton Grove. Wildlife that were provided with extra care due to illness or injuries included: a coyote pup, squirrels, rabbits, and birds, to name a few. These animals were transported to nearby wildlife rehabilitation centers for continued care. Wildlife rehabilitators work tirelessly to aid these animals in their recovery process, so that they can be released back into the wild when they are healed. Moreover, the reconstruction of several bird and bunny nests by ACO Glowacz was vital to keeping juvenile wildlife with their mothers, as it greatly increases their chances of survival.

The well-being and safety of both residents and domestic animals in the Village of Morton Grove is a top priority of the Morton Grove Police Department. This year, there were 4 dangerous dog declarations, in accordance with the Village's codes and ordinances.

#### **Animal Control Officer**

ACO Glowacz is pleased to announce that an Animal Control section has been added to the Morton Grove Police Department website. Furthermore, ACO Glowacz issues a monthly animal publication to educate residents on various animal matters. These valuable resources address and educate the public on domestic animals, wildlife animals, and rodent control. Animal publications are accessible to residents via the Morton Grove Police Department's Facebook page, the MGPD Animal Control website page, or by contacting ACO Glowacz. Continue to be on the lookout for the next ACO publication!

The Morton Grove Police Department is excited to share that a new animal control truck was purchased at the end of 2022, and will be ready for use in 2023. This new vehicle will include upgraded animal control equipment, kenneling options (for a variety of animals), and additional safety features. Moreover, the vehicle will be used for a variety of calls, including: animal transportation, traffic control, and other emergency responses. Be on the lookout for the new ACO truck out on the road this spring, and be sure to say "hello" to ACO Glowacz!

2022 was certainly another exciting year of animal encounters, and ACO Glowacz is looking forward to a successful 2023 season!



#### Therapy Dog—"Law Enforcement Healers"

We are excited to announce that in August of 2022, the Morton Grove Police Department created a therapy dog program, "Law Enforcement Heelers." In conjunction with the MGPD Peer Support Team, we implemented a therapy dog program to aid our employees in times of personal and professional difficulties, and to help anticipate and address the potential adverse effects on their personal and professional lives. This is a valuable tool in fostering dialogue and communication between Department employees.

The goals of the program are:

- To help build a positive work environment, and increase Department morale
- To aid officers in coping with issues related to their mental and physical health
- To provide officers with the opportunity to interact with a therapy dog, that will offer them a way to destress and cope after critical incidents, or during a difficult/stressful work day
- To help produce social interactions among officers who have been through life-changing experiences, both on and off the job

#### **Child Seat Installation**

CSO Glowacz is delighted to continue serving the Village of Morton Grove as a Certified Technician for child seat installations. The Morton Grove Police Department is also excited to announce that CSO Moreno completed his training as a Certified Technician in November of 2022. CSO Glowacz and CSO Moreno aid residents by educating them in the proper selection, installation, and use of car seats and booster seats. With two certified child seat Technicians, we are hoping to double our impact in the community by providing additional car seat checks and new installations in the upcoming year.



Through in-person installations and hands-on educational meetings, CSO Glowacz was able to assist 33 families with installing their car seats this year. Each resident that has a car seat checked or installed for the first time is provided with a "Child Seat Safety" educational handout, which guides residents in choosing the appropriate car seat based on the Illinois Child Passenger Protection Act—whether it's a rear-facing car seat, forward-facing car seat, booster seat, or seat belt.

In November, CSO Glowacz continued her car seat education, by attended a Technician Skills Building class; to learn more about current changes in car seats, and the new car seat models that are available to the public. CSO Glowacz also has additional training for transporting children with special health care needs; including how to install specialized restraint systems.

CSO Glowacz was excited to be able to donate 2 child seats to families in need in 2022. The Morton Grove Police Department is hoping to obtain 4 new child seats in the 2023 year, which again will be donated to families in need.

We are happy to provide virtual educational meetings to residents who would like to continue taking added precautions during this time. Resources for public remote education continue to be available to residents, upon request; including steps that you can do at home for a car seat checkup. Proper safety protocols continue to be in effect for residents scheduling a car seat installation session.

If you are a Village of Morton Grove resident, please feel free to contact the Morton Grove Police Department—CSO Glowacz and CSO Moreno would be happy to schedule a meeting with you to ensure that your car seats are installed correctly, while also teaching you how to utilize and confidently install a car seat on your own.

#### **Field Services Division**

The Morton Grove Police Department has nine sworn personnel assigned full time within the Field Services Division performing a wide variety of tasks and assignments. Personnel assignments within this division are; Detective, Tactical Officer, and Community Liaison Officer.

- **<u>DETECTIVES</u>** The Detectives' main responsibilities include conducting criminal investigations, identifying and apprehending criminals in follow-up investigations, conduct juvenile investigations and are responsible for the background investigations of civilian and sworn personnel.
- <u>TACTICAL OFFICERS</u> Tactical Officers conduct criminal intelligence gathering, surveillance, crime pattern
  analysis, undercover operations, vice and narcotics operations, liquor gaming and tobacco enforcement
  compliance checks. Tactical Officers also perform many self-initiated tasks that include anti-crime patrols
  and hot spot saturation.
- <u>COMMUNITY LIAISON OFFICERS</u> Community Liaison Officers are sworn officers that primarily focus upon crime prevention and community involvement.

#### **Task Force Assignments**

Field Service personnel are assigned to task force duties that benefit Morton Grove through the utilization of other law enforcement agencies.

- <u>NORTAF Violent Crimes</u> NORTAF Violent Crimes is a multi-jurisdictional task force that utilizes investigators from surrounding communities to assist in solving homicides and other violent crimes. Commander Johnson is assigned as a Team Leader. Detective Schuette is the forensics supervisor.
- <u>NORTAF Burglary</u> NORTAF Burglary is a task force that focuses primarily on the identification and suppression of residential and commercial burglaries. This task force also performs surveillance and tracking of the persons that commit burglaries. Detective Johanson is assigned to this task force as a team leader.
- <u>NARCINT</u> NARCINT, the Narcotics and Currency Interdiction Task Force, is part of the High Intensity Drug
  Trafficking Area group (HIDTA). NARCINT is responsible for the interdiction of narcotics flowing through
  Morton Grove and our surrounding communities. One Morton Grove detective is assigned to this task
  force.
- ICAC The Internet Crimes Against Children Task Force Program is a national network of 61 coordinated task forces representing over 4,500 federal, state, and local law enforcement and prosecutorial agencies. These agencies are continually engaged in proactive and reactive investigations and prosecutions of persons involved in child abuse and exploitation involving the internet. One Morton Grove detective is assigned to this task force.

#### **Field Services Division**

#### **2022 Investigation Statistics**

In 2022, detectives and tac officers were assigned 456 cases that included property crimes, crimes against persons, narcotics, vice, background investigations, and other miscellaneous cases. The field services division made 74 arrests and obtained 11 arrest warrants. The rest of the cases were cleared by one of the criteria listed below.

#### Case Dispositions:

- Cleared by Arrest An arrest is made.
- Cleared by Warrant An arrest warrant has been issued for the offender.
- Cleared Exceptionally Probable cause to make an arrest is present, but an arrest was not made
  for a variety of reasons that can include; restitution being made, the victim not wishing to prosecute, or a non-traditional closure of the case that satisfies the victim.
- Unfounded A crime did not occur.
- Administratively Closed The case is closed due to a lack of investigative leads or evidence.
- Referred to Other Agency The crime or incident occurred in another jurisdiction.
- **Documentation Only** The report and investigation were created with the express purpose to assist the victim or complainant in receiving assistance from other agencies or judicial process.





#### **Community Liaison Unit**

The Community Liaison unit is responsible for the very popular Officer Friendly program which allows our officers, Officer Lietz and Officer Jurasz, to interact with all of the schools, students, and staff. The unit is also responsible for creating and participating in programs that enhance the relationship between the Police Department and the community. #### **Evidence and Property Section**

The Evidence and Property Section is responsible for the safe secure storage and integrity of any and all evidence or recovered property in the custody of our Department. Other responsibilities are:

- Maintaining clear and accurate records of evidence status.
- Monitoring submitted evidence/property to ensure it's compliant with Department Policy.
- Promptly submitting evidence to forensic laboratories.
- Processing subpoenas.
- Managing prisoner property.
- Disposal of evidence/property in accordance with Department policy, State, and Federal laws.
- Identify and return found property to the rightful owners.
- Donating evidence/property salvaged from disposal.
- Preparing evidence/property for auction that was approved by the Department and Village.
- Managing evidence/property intake and disposal levels.

In 2022, we maintained 7,189 items of evidence/property to include:

- 1,560 items of evidence/property were submitted.
- 1,183 items of evidence/property were destroyed.
- 106 items of evidence/property were returned to their owners.
- 11 firearms were destroyed.
- 161 packages of drug evidence were destroyed.





#### **Support Services**



The Support Services division is staffed by civilian personnel and provides a myriad of professional services necessary to support the wide variety of functions in the Police Department. These services are critical to the efficient operation of the Department as well as to the community members we serve.

Support Services is divided into four major areas of responsibility: Records & Statistical Management, Logistical Services (Budgeting & Fiscal Management), Ordinance Enforcement & Court Services and the School

Crossing Guard Program. Additionally, Support Services assists at accidents and crime scenes, in special events, parking enforcement, and many other functions.

To help achieve its goals, the Division is administered by a civilian manager and staffed with a Records Coordinator, five full-time Community Service Officers and seven School Crossing Guards.

### **Crime Index Offenses**

Crime data compiled by the Village of Morton Grove are categorized to conform to the Uniform Crime Reporting Information System, which allows for comparisons among jurisdictions. Offenses are divided into two groups – Part I and Part II. Part I Offenses (Index Crimes) include the nine crimes that are considered most serious. These are crimes that must be reported to the FBI on a monthly basis by local, county and state law enforcement agencies. The FBI acts as a clearinghouse for the data. Usually, when the news media discusses crime rates going up or down, they are referring to the Index Crimes. Part II Offenses are most other crimes.

### **Juvenile Offenses and Youth Services**

The Juvenile Court Act establishes procedures for dealing with youthful offenders, according to the following categories: 1) abused, neglected or dependent minors; 2) minors requiring authoritative intervention; 3) addicted minors; and, 4) delinquent minors. Members of the Field Services Division are trained to deal specifically with juvenile offenders as our specially trained members of the Patrol Division.

Juvenile crime, like adult crime, is rooted in a combination of social, emotional and economic factors. However, unlike the adult justice system, juvenile justice is based in a rehabilitative approach that attempts to keep kids out of prison as adults. Depending upon the offense committed by the juvenile, options are available that keep kids out of jail and get them the help they may need.

A juvenile contact may involve a juvenile who is a victim or in need of counseling due to other problems that are not criminal. The Department's goal is to utilize these types of contacts to provide youths with an opportunity to recognize that they may need help and obtain appropriate assistance. In furthering this mission, the Police Department has relationships with outside non-governmental organizations (NGO) and works closely with the schools that have more consistent contact with these juveniles in need.

It is the goal of the Morton Grove Police Department to remain proactive in working with youths through various programs in order to educate them and deter their involvement in criminal activity. The categories of crimes that juveniles are charged under consist of status offenses and criminal offenses.




#### **Burglary**

Burglary is a particularly sensitive crime because of the invasive nature of the offense. Generally, burglaries are classified as Residential (dwelling or garage) or Non-Residential (commercial).




Burglaries generally are crimes of opportunity: a burglar identifies the easiest target and strikes. Homeowners and business owners can deter burglars by locking doors, leaving lights on timers, lighting entrance ways, and having good locks and alarm systems in place. The Morton Grove Police Department will provide a free security survey for all home or business owners and provide security information to deter crime.



### **Traffic Safety**


The goal of the Morton Grove Police Department's Traffic Safety Program is to protect the lives of motorists and pedestrians, reduce accidents, and create a safer, more secure community. Higher police visibility in targeted areas serves as a significant deterrent to the motoring public. Coordinated efforts by our Patrol Officers and Tactical Officers target school zones, high volume signal intersections, known excessive speed areas, and problematic intersections. The Police Department works closely with citizens, the Village Engineer and the Traffic Safety Commission to identify safety concerns and problem solve to a reasonable solution for neighborhoods. In 2022, the Police Department issued 1,205 traffic citations overall.

### **Red Light Camera Program**

According to National Highway Traffic Safety Administration statistics from 2010, the State of Illinois was one of the top-five deadliest in the nation for red-light running fatalities. To help combat that, the Village of Morton Grove implemented a Red-Light Safety Camera Program with the purpose to increase traffic safety in the village by reducing red-light running violations, collisions and injuries.

Since July 2012, the Village of Morton Grove has had a Red-Light Enforcement area at the intersection of Waukegan and Dempster. The camera system is maintained and managed by American Traffic Solutions (ATS) and covers both the straight and left turn lanes of northbound Waukegan.

When a possible violation occurs, there is a 2-part vetting process prior to a violation notice being issued. First the video is reviewed by ATS personnel. If they verify the camera was working properly and within the recognized specifications, the violation is forwarded to the police department. The supervisor assigned to monitoring the Red-Light Camera, reviews the evidence and makes the final determination of whether or not a violation notice is issued.

In 2022, the camera was not functional due to intersection maintenance. Once this is complete, the Red-Light Safety Program will resume normal operations.



In 2022, the Morton Grove Police Department conducted over 5,000 hours of training. The training covers topics from criminal law to investigations courses to firearms/defensive tactics to management training to De-escalation/Crisis Intervention training. The department's thirteen supervisors spent over 780 hours on training in Management and Supervision. One patrol sergeant was sent to the ten week School of Police Staff and Command at Northwestern University. This a very demanding course that is attended by supervisors from around the world and cover a multitude of topics related to police supervision and leadership.

The Morton Grove Police Department continued to address the increasing number of encounters of subjects in mental health crisis with CIT/De-escalation training. CIT training is a proven strategy for helping police handle mental health crises in ways that are safer for police and better for citizens. The Morton Grove Police Department is committed to sending all sworn police officers to a 40-hour Crisis Intervention Team training course. The department committed 254 hours to CIT/De-escalation training.

The Morton Grove Police Department trains its Officers based on State requirements, Department/ Community needs, and individual officer's desire for self-improvement and personal development. The department utilizes local training facilities to accomplish its training goals. NEMRT, the North East Multi-Regional Training facility, offers hundreds of courses each year at local police departments and is vital to the completing the various State mandated training requirement. The Suburban Law Enforcement Academy located at the College of DuPage is where the department sends officer for their basic academy and also to attend various continuing education classes on law enforcement. Also, online training is conducted monthly at the Police Law Institute covering topics such as arrest, search, and seizure, anonymous tips, and vehicle pursuits.

#### **Field Training**


Field Training is a rigorous structured program, lasting 60 days, designed to teach and observe a probationary police officer in the field dealing with real world police interactions. The probationary police officer is accompanied at all times with a Field Training Officer. The department has trained eight officers to be Field Training Officers. These are officers who have demonstrated exceptional professionalism and passion for law enforcement. Field training normally lasts three months before an officer is allowed to conduct solo patrol. Once on solo patrol, he is evaluated each month by his supervisor and has a meeting with the Field Training coordinator to track his progression. Each officer is considered on probation for the first two years of his employment. This ensures completely vetted and well trained officers are serving our community.


#### **Firearms Training**

The Morton Grove Police Department utilizes its indoor gun range to conduct monthly training courses for all sworn officers. Officers must complete qualifying course for handguns and patrol rifles with a passing score. Other courses include room entry, ballistic shield use, close quarter battle drills and weapons malfunction drills. Officers are also trained to shoot in low light situations, different positions and while wearing tactical equipment. These course are conducted to familiarize officers with the different equipment so they are prepared when needed.

The Morton Grove Police Department issues duty pistols to all sworn officers. The pistol is the Sig Sauer P320 9mm. The Department also provides AR-15 patrol rifles to officers. Officers are able to purchase their own rifles to use on duty. These must meet department standards and be inspected by Department armorers.

In 2022, the Morton Grove Police Department Firearms Training Courses were approved by the Illinois Law Enforcement Training and Standards Board (ILETSB) through the North East Multi-Regional





#### **Scenario Based Training**

The Morton Grove Police Department engages in a quarterly Scenario Based Training Program. Participating in scenarios which are designed to simulate the real world obstacles that officers are faced with during the course of their duties, allows personnel to improve their tactical abilities. Training methods and models used in the Scenario Based Training Program are based upon the leading research and methodology within the law enforcement community. The program is designed to test the skills that officers are taught in the other internal training programs such as the Firearms Training Program, Defensive Tactics Program and Tactical Medical Training.

The Morton Grove Police Department utilizes various technologies in the implementation of the Scenario Based Training Program, such as Simunitions, Impact Reduction Suits, Tasers, OC Spray, and de-escalation techniques. The use of these technologies allows personnel to be inoculated to the stresses of real world, live fire scenarios while eliminating any of the associated dangers.



The Scenario Based Training Program is the marquee of the Morton Grove Police Department training and its continuation ensures the optimum performance of its sworn officers and the continued delivery of the most professional police services possible.



#### **Defensive Tactics Training**

Sworn Members of the Morton Grove Police Department respond to thousands of calls and make hundreds arrest a year. Some of those calls have the potential to escalate into physical confrontations and resistance. Officers must overcome these physical attacks and resistance with the minimal force necessary to affect an arrest. In order to prepare for those situations, the Morton Grove Police Department strives to give their personnel the best training possible.

Every month, the officers are trained in some aspect of physical confrontation to include instruction in the use of restraints, two officer control and arrest tactics, ground defense, weapon retention and Conducted Energy Weapons. These techniques are designed to minimize injuries to individuals as well as officers. The training cadre is afforded expert certification from a number of leading institutions



including NEMRT, Pressure Point Control Tactics, Force Science Institute and Rectitude Training LLC.

In 2022, The Morton Grove Police Department added the BolaWrap device to patrol. This device can temporarily restrain individuals from a safe distance by discharging a Kevlar cord which wraps around an individual's arms and/or legs restricting their mobility. Four officers successfully completed the Force Science Course. Force Science advances expert decision making, superior performance and honest accountability in public safety. In addition, the Morton Grove Police Department Defensive Tactics Courses were approved by ILETSB and NEMRT.

#### **CPR Training**

All Morton Grove Police Department personnel are certified in Basic Life Support for Health Care Providers through the American Heart Association. This two-year certification trains personnel in the following areas: adult, child, and infant CPR; automated external defibrillator (AED) usage; rescue breathing; and naloxone considerations. Ofc. Narcisa, Ofc. Lietz, Ofc. Crowe, and Ofc. Zachacki are currently instructors for the police department. The police department maintains five AEDs. One is kept at the police station and the other four are carried by patrol officers to be utilized on calls for service. All of the AEDs are checked daily to ensure the proper pads are connected and the battery life is sufficient. The AEDs are also annually calibrated by a Zoll company representative at the Morton Grove Fire Department. In 2021 we added bag valve masks (BVM) to our AED kits. BVMs allow the victim to be resuscitated with room air which contains a higher oxygen concentration when compared to exhaled air via a pocket mask. We also added gauze, a pressure bandage, an occlusive dressing (used for covering penetrating thoracic trauma), an emergency blanket, and a tourniquet to all of the AED kits. The first aid kits were added to the AED kits so that first responding officers could also render aid when encountering traumatic injury, not just cardiac arrest. The Morton Grove Police Department conducts CPR and AED refresher training throughout the year at roll call training. Officers are also tested on their skills when participating in scenario-based training throughout the year. We continually strive to improve and provide the highest level of service to our residents.

### **Specialized Training**

#### **Crisis Intervention Team (CIT) Program**

The Morton Grove Police Department continued to address the increasing number of encounters of subjects in mental health crisis with Crisis Intervention Team (CIT) training. CIT is a proven strategy for helping police officers handle mental health crises in ways that are safer for police and better for citizens. In 2022, two officers attended the Illinois Law Enforcement Training and Standards Board (ILETSB) state-certified 40 hour CIT training.



During the week long training, the officers received intensive training on recognizing and addressing individuals in the community who have a mental illness or other behavioral disabilities. These officers were trained as resource specialists who can provide an immediate and effective response to calls involving a mental health crisis. The course included presentations by behavioral health specialists, experienced field officers, and representatives from regional service providers. After an initial presentation, the officers participated in valuable exercises that simulated some of the hallucinations that many individuals with a mental illness may experience. While listening to a series of recorded voices, officers rotated through workstations where they were asked to perform cognitive tasks. This allowed them to gain insight into what an individual who is subject to such a barrier experiences.

Later in the week, each officer had a unique opportunity to participate in discussions with individuals who have a mental illness and/or their family members. These firsthand accounts of living with mental challenges provided insight for the officers outside of a typical field encounter and allowed each officer to better understand the nuances of specific disorders.

Finally, the officers participated in realistic scenarios portrayed by professional actors that included suicide interventions, de-escalating a potentially violent situation, responding to a call involving an individual experiencing paranoia, and/or a person interacting with a peer in a manic episode behaving in an inappropriate manner. All scenarios were facilitated by and evaluated by trained CIT officers.

The Police Department has found this course to be very progressive and extremely helpful when our officers interact with our citizens who have a mental illness or behavioral disability. The Morton Grove Police Department is committed to sending all sworn police officers to the 40 hour Crisis Intervention Team training course.

#### **Illinois Traffic Safety Challenge**

The Illinois Traffic Safety Challenge (ITSC) is a friendly competition between similar size and type of law enforcement agencies. It is a program coordinated by the Illinois Association of Chiefs of Police (ILACP) Traffic Committee and supported by a National Highway Traffic Safety Administration (NHTSA) grant administered through the Illinois Department of Transportation, Bureau of Safety Programs and



Engineering (BSPE), as well as much-appreciated funding from private entities. The Morton Grove Police Department competed in the Championship Division and was awarded the Railroad Specialty Award for the 2021-2022 Illinois Traffic Safety Challenge.

The Challenge is much more than a peer competition. It is a template for law enforcement agencies to identify traffic issues, plan strategies, reduce social harm and improve the quality of life in their communities. The Challenge helps agencies demonstrate successes to their government officials, community leaders and citizens. The Illinois Traffic Safety Challenge provides law enforcement agencies with an opportunity to contribute to the Illinois' Strategic Highway Safety Plan and have a significant impact on the reduction of crashes, deaths and associated injuries across the state.



The Morton Grove Police Department takes its responsibility to serve the citizens seriously. One of the important ways this is accomplished is through crime prevention programs. All of these various programs are designed to help make the citizens more vigilant in their own safety and allow us to better serve them.

#### **Community Partnership**

All members of the Police Department are responsible for the suggestions and concerns of citizens, representatives of schools, religious institutions, businesses, and other government or community organizations. The continuous exchange of information is critical to the mission of the Police Department. This process provides us with an opportunity for rapid response to community needs. Citizen concerns should be directed to the Police Department immediately to allow us time to investigate events early while they may still be minor in nature. This important process also helps the community impart concerns to their Police Department that might otherwise not get reported.

ice cream, a 51-foot blow up obstacle course, a bouncy house, raffle prizes and more.



#### **Honor Guard**

Since 1895, the Morton Grove Police Department has served the Village of Morton Grove with distinction and honor. Throughout that long history, over 150 men and women have served as police officers in Morton Grove with 46 currently on active duty. In the 119-year history of the Morton Grove Police Department, one officer paid the ultimate sacrifice in service to Morton Grove. Officer Barry Shalin was killed on October 9, 1989 when he was run over by a drunk driver while he was working a patrol shift.

The Morton Grove Honor Guard was established in 2009 to honor Officer Shalin on the 20<sup>th</sup> anniversary of his death and continued on as a unit to honor the commitment and sacrifice that police officers provide on a daily basis.

#### **Police Explorers**

The post had meetings twice a month where explorers receive hands on training in various police related topics including leadership, drug awareness, traffic stops, building searches, evidence collection, traffic control, criminal law, arrest, search, and seizure law, and a number of other topics. Besides learning how to be the police, Explorers participate in many community activities such as the 4<sup>th</sup> of July parade, fireworks, carnival activities and charity events. ### **Partner Agencies**

The Morton Grove Police Department investigates crime and makes arrests through the diligent efforts of police department employees working together. On many occasions the police department works with other law enforcement agencies to solve crimes that affect our region, the State of Illinois, or even other states. Some of the crime patterns are long term and necessitate the formation of targeted working groups that have since evolved into task forces. The Morton Grove Police Department is a part of or contributes to many regional, state and federal task forces.

#### **NORTHERN ILLINOIS POLICE ALARM SYSTEM**

The Northern Illinois Police Alarm System (NIPAS) represents a joint venture of suburban municipal police departments in the Chicago metropolitan area. To ensure effective police mutual aid in times of natural disasters and to protect life and property during unrest, the Morton Grove Police Department joined NIPAS. NIPAS is further divided into two additional mission specific teams; Mobile Field Force and the Emergency Services Team. Morton Grove personnel are assigned to both teams.



#### **NORTH REGIONAL MAJOR CRIMES TASK FORCE**



The Morton Grove Police Department is a longtime partner in this regional task force. NORTAF Major Crimes assists Morton Grove and other law enforcement agencies from the Lake County border to the north border of the City of Chicago. Since 1997, NORTAF Major Crimes and the Morton Grove police personnel that are assigned have investigated numerous homicides and non-parental kidnappings.

#### **NORTAF-MAJOR CRASH ASSISTANCE TEAM (MCAT)**

MCAT is a regional task force that investigates and assists in major vehicle crashes resulting in serious injury or death. Members assigned to this task force receive advanced training in evidence collection standards for vehicle and pedestrian related crashes while also receiving training in accident reconstruction techniques.



### NARCOTICS AND CURRENCY INTERDICTION TEAM (NARCINT)

NARCINT is a state wide task force that utilizes a cooperative approach to narcotics interdiction efforts. Working with investigators from other suburbs and the State of Illinois, a Morton Grove detective helps interdict narcotics and human trafficking organizations.

### **Partner Agencies**

#### **GLENVIEW PUBLIC SAFETY DISPATCH CENTER**

In September of 2012, the Morton Grove Police Department contracted with the Glenview Public Dispatch Center (GPSDC) to provide dispatch services. GPSDC provides contracted dispatch services to 12 police and fire departments, and serves eight different municipalities.

Along with the dispatch service, GPSDC provides numerous technological benefits to the Morton Grove Police Department such as a comprehensive Law Enforcement Records Management System; a self-contained computerized report writing system that allows officers to create reports in their squad cars and send them to supervisors; mapping capabilities that allow officers to see events and locations in real time; and computer aided dispatch functions that share prior call information with responding officers.



#### STARCOM21 RADIO NETWORK



GPSDC and the members of the Morton Grove Police Department use radios connected to the STARCOM21 network. STARCOM21 is a groundbreaking public/private

partnership with Motorola Solutions envisioned and commissioned by the State of Illinois to enable seamless, interoperable communications among State, local and federal government users. The network allows members of the Morton Grove Police Department to communicate with these users, and each other, anywhere in the State. It also enables enhanced response to disaster and emergency situations and allows the State to effectively address homeland security concerns.

The STARCOM21 network is owned and operated by Motorola Solutions and currently serves more than 45,000 subscribers from various State, local and federal government and non-governmental entities. This includes the neighboring communities of Niles, Glenview, Skokie, and many others in the surrounding area. It is a statewide, 700/800 MHz, Project 25-compliant, digital, trunked voice radio network that is open to all public safety and public service agencies in the State of Illinois.




