- **Drainage Plan** prepared by licensed engineer for detached garages \geq 400 square feet (4 sets)

Required Approvals: Before a permit is granted, approval is required for the following:

- \circ Building \circ Engineering (\geq 400 square feet)
- Electrical Zoning

<u>Required Inspections</u>: When this permit is approved, the following inspections will be made. The applicant is required to request these inspections at least (24) twenty-four hours in advance, and their authorized agent must be present.

- o Concrete Pre-Pour
- Final Building
- o Final Electrical
- Final Engineering (\geq 400 square feet)

When this permit is granted, the following fees must be paid. The amount of the fees will be calculated based on the plans submitted.
