

**MINUTES OF THE MARCH 8, 2016
MEETING OF THE ADVISORY COMMISSION ON AGING
American Legion Memorial Civic Center
Morton Grove, Illinois 60053**

Commissioner Labunski moved to approve the minutes of the February 9, 2016, meeting seconded by Commissioner Rupkey. Minutes were unanimously approved.

Old Business:

Commissioner Rupkey stated the State of Illinois will no longer send out emission test reminders. You can sign up for an e-mail reminder. The license plate tag renewal will not be sent out if your car has not been cleared through an emission test. She suggested that the police department address this issue on Channel 6 so that residents will know they will not be receiving renewal notices for stickers or emissions and guide them. It was suggested that information be put in the newsletter.

Discussion centered around getting information out to the residents. The printed word is the preferred method; however, there are time limits and costs associated with the printed word.

Ms. Paz, Mather's LifeWays, stated that residents do come to them and requests various information. Word has spread that Mather's LifeWays is a source for information.

New Business

Share A Ride Program was discussed by Ms. Philippart. Residents do try to provide a ride for other residents; however, the Civic Center is a connecting point for all to help with ride sharing.

Commissioner Labunski questioned whether there was potential that a bus could be acquired. Pace does have rides but it is very difficult to get accepted by Pace. Ms. Philippart and Ms. Paz will research ride sharing options.
