Morton Grove Village Code Section 3-3A-8 provides the option for a Defendant to waive his/her right to a formal hearing and have the Citation adjudicated by the Hearing Officer based solely on evidence submitted in writing. Defendants electing this option should complete and sign this form, attach a copy of the Citation and all evidence you wish to be considered, such as photographs, witness statements, vehicle registration, proof of payment, etc. Witness statements should be notarized or made under penalty of perjury by a person with first-hand knowledge of the facts. Make sure the documents are legible and complete. Send copies, not originals; evidence will not be returned. All documents must be received by the Village at least five (5) business days before the scheduled date of the hearing. The Hearing Officer shall decide each case and issue an Order on or before the scheduled hearing date. If the Defendant is found liable, a fine and a \$50.00 Administration fee shall be assessed against the Defendant. A copy of the Order shall be mailed to the Defendant within fourteen (14) days after it has been issued by the Administrative Hearing Officer.
