Minutes of the February 14, 2017

Meeting of the Community Relations Commission

Pursuant to proper notice in accordance with the Open Meetings Act, the regular meeting of the Community Relations Commission was called to order at 6:30 pm. on February 14, 2017, by Chairperson Arcelia Pimentel.

Chairperson Pimentel announced the first order of business was approval of the meeting minutes of January 10, 2017. Commissioner Laliwala moved to approve the minutes. Commissioner Downing seconded the motion. Minutes unanimously approved by voice vote.

Mike Simo, Police Chief, was introduced to the CRC and gave a recap of the recent event that took place in Morton Grove on January 29, 2017. The event was "Empowering Diverse Community" and was a scheduled walk thru Morton Grove. The walk began on Menard and headed north to Dempster, west to Fernald and south to Capulina, and ending at the starting point at the Muslim Community Center on Menard. The police dept was scheduled in all areas to handle the crowd which estimated a total of 1500 – 2000 participants. Simo added that when events like this take place, professional agitators find out and will show up and try to cause problems but fortunately this did not happen. For future events like this the police dept needs to be involved with the planning in order to prevent any problems. The 4th of July is a similar event that takes a lot of man power and overtime in order to prevent any incidents.

Elizabeth Jones, the pastor at St Lukes Church, reviewed her plans for the 2nd annual peace vigil on the 13th of May in conjunction with the Farmers Market at the Civic Center. Ms. Liston added that this sounds like a joint effort with other houses of worship and something that the commission would like to get involved with. Ms. Jones will reach out to the other houses of worship and then contact the CRC and inform what areas that the commission can do to support this effort.
