Pursuant to proper notice in accordance with the Open Meetings Act, the meeting was called to order at 6:02 p.m. by staff liaison Terry Liston. In attendance were:

The committee discussed a standing meeting date and time and agreed further meetings would be on the third Tuesday each month at 6:00 PM.

Commissioner Schultz then move to approve the minutes of the April 8, 2021 meeting. The motion was seconded by Commissioner Laliwala and approved unanimously via a roll call vote.

The Commission then reviewed a proposed article submitted by Commissioner Corelli. It was the consensus of the subcommittee that Commissioner Corelli should be applauded for her efforts and that Commissioner Schultz would work with her to refine the article.

The commission then discussed an e-newsletter article to be published on the third Friday of May. Commissioner Schultz recommended that the article highlight composting and choices residents currently had. She offered to draft a short - six lines or less article with a link to the Village website sections on composting. The commission also discussed and decided that the June newsletter article be directed towards local businesses and highlight the upcoming Expo.

A discussion then ensued about the Kids for a Greener Morton Grove contest. Currently the program was not being promoted to individual classrooms. The commissioners agreed that outreach needed to be directly to principals and art teachers. The commissioners agreed to discuss the logistics for the announcement of the winners of the contest at the June 12 French Market with the entire commission at it's June 1 meeting.
